

## **ABOUT THE PARTNERSHIP**

The **Wear Catchment Partnership (WCP)** brings people together to plan work 'at the catchment scale' on our local rivers and streams.

We aim to listen to all partners' views and help focus resources and effort to where they can make the biggest difference to the catchment by working together.



The WCP is hosted by the Wear Rivers Trust (WRT) and supported by Catchment Coordinators from the Environment Agency (EA) and Northumbrian Water (NW). The Steering Group is currently chaired by the Durham Heritage Coast and will rotate around partner organisations on an annual basis.

# LATEST NEWS

## Seascapes bid submitted

SeaScapes - Tyne to Tees, Shores and Seas is the UK's first marine Landscape Partnership Scheme, recently submitted by Durham County Council. If successful it will secure £5m to deliver a programme of 23 projects over four years to benefit coastal heritage, the marine environment and the local communities of South Tyneside, Sunderland, Durham and Hartlepool. The programme builds on the successful series of partnerships locally, including the Turning the Tide Partnership, the Heritage Coast Partnership and the Limestone Landscapes Landscape Partnership. The total project budget is comprised of £2.9m from the National Lottery Heritage Fund (NLHF), and £2m of partnership funding. We are expecting a decision in the Spring.

## River Basin Management Plans: Challenges and Choices Consultation - get involved!

- The Challenges and Choices consultation is open until April 2020. There are 12 videos, covering an overview and introducing 11 themes with actions. These introduce context and ideas on how important the water environment is, current and future challenges, how we can work together, and who should pay. This is the 2<sup>nd</sup> consultation, and the 3<sup>rd</sup> and final one in October 2020 on draft plans will be joint with Flood and Coastal Risk Management Plans. The EA are looking for evidence of wide engagement and encouraging individuals, organisations, and partnerships to respond.

## **NWG Environmental Performance Success!**

Northumbrian Water scored 4\* in the Environment Agency's latest Environmental Performance assessment of water companies – the only company to be top rated. Bathing Water results now in for the 2019 bathing water season show that four out of the five beaches on the Wear coast are rated as excellent quality (Seaburn, Roker, Seaham and Crimdon). Seaham Hall is currently at Good status. We'll be working hard with our partners in 2020 and beyond to protect and improve the quality of rivers and beaches.

## **PROJECTS IN PROGRESS**

#### **Creating a Better Wear Estuary**

Work has begun on an exciting new study of the River Wear Estuary. Led by Groundwork, and EA funded, the study will look at opportunities for ecological improvements on the river estuary.

Outputs will include a range of actions to help improve the estuary and the formation of a new Estuary Partnership to coordinate their delivery.
